Country Park Accreditation – We have been successful in renewing our accreditation for the park with the government department Natural England. We reapply every 3-years and provide evidence that we still meet all the criteria for the scheme. There are currently only 3 parks accredited in the Southeast and 30 in England. Thanks to everyone who assists with the management of the park and run events as this all contributes to the success of the park. <u>More...</u>



Orienteering – Virtual orienteering courses are now available starting from either Tonbridge Castle extending to Tonbridge Racecourse Sportsground or Haysden Country Park. This is a new fun way to learn orienteering at your own pace, you do not have to join or be an expert to take part. The courses are free for anyone to use and use the **MapRun** app which can be downloaded to your mobile device has a map. If you prefer copies of printed maps these can be purchased from the Castle Gift Shop or the Café in the Park at Haysden Country Park for £1. Our thanks go to the Saxons Orienteering Club for setting this up with us.

Public Space Protection Orders

Public Space Protection Orders – public consultation is now completed, and these have now been adopted by the Council. £100 fix penalty notices or £1000 maximum fines on summary conviction now apply for:

- **Alcohol** it is an offence to continue drinking when asked to stop by an authorised officer
- Barbeques these are not permitted in the park
- **Camping** unauthorised camping is not permitted in the park
- **Dogs** you must clear up your dog fouling, no dogs allowed in the children's play area, dogs on leads by instruction by an authorised officer, dogs on leads in <u>all</u> car parks, and the maximum number of dogs per single person is six
- **Public urination/ defecation** it is an offence to go to the toilet in a public place accept in a public lavatory.
- Drones may not be flown on any Council owned land
- No swimming, bathing, or boating except where specifically authorised
- Vehicles on public open spaces no person may park save in a designated parking place. <u>More...</u>



Sharps Bridge – Kent County Council has now replaced Sharpes Bridge with a wider new bridge with ramps at each end. The ramps were a requirement of the Environment Agency consent. The bridge has now been opened a few weeks. Reinstatement around the newly surfaced Barden Lake path will be carried out in due course.

Other news

Natural history -

Volunteer Alan over recent months has continued his surveys of the park conducting surveys discovering many new mosses, lichens, and fungi.

Great crested newt licenced surveys – as part of a wider Kent Pond survey a volunteer working for the Kent Amphibian and Reptile Group is about to start a survey to see if we have these newts present in the park. <u>More...</u>

Zebra Mussel survey - a PhD student from the University of Cambridge is currently conducting a study to discover more about these invasive non-native mussels which are present in our lake and throughout the UK.

Staffing – Michael Harris Outdoor Manager, has now left the Council and James Fay has been appointed as Interim manager.

Stephen Henderson who covered the Park Ranger role has now left the Council, we welcomed back Jane Brazier our ranger after her maternity leave.

Sponsored seat scheme – We continue to see a rise in enquiries and demand for seats and several more have been installed around the park. Over the last two years twenty new seats have been installed in the park.

Green Flag Award judging – The park has been entered for the award again this year, judging will take place shortly and announcement will be made in the summer. <u>More...</u>



Work completed.

- Revetment work around Barden Lake
- We have tarmacked a small part of the Children's play area, around the toddler play equipment using funding from a developer contribution
- Replaced two new litter bins outside the toilets (two bins had worn out)
- Approved access for more contractors wanting to conduct maintenance work on

their land

- Investigated another use for Tile Barn Field but this use was not feasible
- Planting of trees by the EA as mitigation for the Leigh Barrier works
- Council website updates adding events etc.
- Purchased some new volunteer clothing for the HCPV
- Avian flu risk assessment and protective equipment ordered
- New seat installed at Haysden Water thanks to another sponsor
- Tree inspections highlighted issues with a few trees which have been reduced or felled
- Botany Pond removal of silt and vegetation EA mitigation works

Work in progress

- Management plan rewrite ready for a start date in January 2025
- An onsite market survey of visitors will be conducted this summer, in preparation for the new management plan
- Our Access Audit will also be reviewed, in preparation for the next management plan
- The dipping platform is closed as it is unsafe, awaiting repair or replacement budget prices obtain but there is no funding for this project at present
- Waymarking project some volunteers have started work planning circular routes around the park using the free GoJaunty smartphone app
- Disabled fishing platform replacements at Barden Lake we have been working on a grant proposal with the Angling Society
- Exterior redecoration of the toilet block being arranged via Property Services
- Mural being repaired for the gates
- Carry out a Breeding Birds Survey thanks to our volunteer Martin
