

# Planning Enforcement

## Privacy Notice (How we use your information)

**The categories of information that we collect, process, hold and share include:**

- personal information (such as name, address, contact details)

## Why we collect and use this information

We use your data to:

- enable us to carry out specific functions for which we are responsible
- take any necessary enforcement action

## The lawful basis on which we use this information

We collect and use this information for the purposes of carrying out our functions under the Town and Country Planning Act 1990

## Collecting this information

Whilst the majority of the information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the data protection legislation, we will inform you whether you are required to provide certain information to us or if you have a choice in this.

## Storing this information

We hold your data for 11 years

For cases resulting in a Notice being served, for as long as we are required to hold the Register of Enforcement and other Notices.

## Who we share this information with

We routinely share information with:

- Legal services
- Any Court as required by the action taken after service of a notice

## Why we share this information

We share data with Legal Services and the Courts under The Town and Country Planning Act 1990. This data sharing enables enforcement proceedings to be carried out in the public interest.

## Public Register

The Council is required to keep a public register which records details of certain authorisations it issues. This register may contain personal data.

## Requesting access to your personal data

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing

- claim compensation for damages caused by a breach of the Data Protection regulations
