SECTION 1 - INTRODUCTION

Purpose and Content of this Annual Monitoring Report (AMR)

- 1.1. This Annual Monitoring Report (AMR) has been prepared in accordance with the requirements of Section 35 of the Planning and Compulsory Purchase Act 2004 as amended by the Localism Act and with the detailed requirements of the Town and Country Planning (Local Planning)(England) Regulations 2012 Regulation 34. The 2017 AMR is the eleventh to monitor the Local Development Framework (LDF) and emerging Local Plan.
- 1.2. It should be noted that the AMR covers the twelve-month period from 1st April 2016 to 31st March 2017. Anything that has happened subsequent to 31st March 2017, apart from progress with the Local Plan, is not specifically covered in this report.

SECTION 2 – LDF AND LOCAL PLAN PROGRESS

Local Development Scheme

2.1. The current Local Development Scheme (LDS) for the Local Plan was revised and approved by on the Council's Cabinet at the meeting on 25thJuly 2017 – See Figure 1.

The Development Plan Documents

- 2.2. The three First Tranche DPDs were submitted to the Secretary of State on 1 September 2006. The Core Strategy was adopted by the Council on 25 September 2007. The Tonbridge Central Area Action Plan and the Development Land Allocations DPD were both adopted by Council on 22 April 2008 in line with the approved LDS of the time.
- 2.3. The Managing Development and the Environment DPD was submitted to the Secretary of State on 31st July 2009 and was adopted on 20 April 2010 in line with the approved LDS. The Saved Policies Compendium was updated accordingly. The MDE DPD has been monitored since the 2010/11 period.

Supplementary Planning Documents

- 2.4. The following Village Design Statements and other documents have been adopted as a material consideration for development control:
 - Shipbourne Village Design Statement (part adopted as SPG), February 2002
 - East Malling Village Design Statement, May 2004
 - Kent Downs AONB Landscape Design Handbook, January 2005
 - Managing Land for Horses: A Good Practice Guide, July 2011
 - Plaxtol Village Design Statement, April 2005
 - AONB Management Plans for the Kent Downs and the High Weald (March 2014)
- 2.5. The following Supplementary Planning Documents have been formally adopted:
 - Kent Design, July 2006 (supplementary to Core Policy CP24)
 - Affordable Housing SPD, July 2008 (supplementary to Core Policies CP17 and CP19)

Kent Design was originally adopted pursuant to Saved Local Plan Policy P4/11. This has now been superseded by Core Policy CP24 which has the same effect. It is therefore now regarded as being supplementary to the new policy.

2.6. The Character Area Appraisals SPD pursuant to Policy SQ1 in the MDE DPD has been adopted. This is a series of separate volumes dealing with all of the main built-up areas in the Borough. It was prepared in three tranches:

National Planning Policy Framework

- 2.7. The National Planning Policy Framework (NPPF) was published on 27 March 2012. This is a key part of the Government's reforms to make the planning system less complex and more accessible, to protect the environment and to promote sustainable growth.
- 2.8. The NPPF sets out the Government's planning policies for England and how these are expected to be applied. It sets out the Government's requirements for the planning system only to the extent that it is relevant, proportionate and necessary to do so. It provides a framework within which local people and their accountable councils can produce their own distinctive local and neighbourhood plans, which reflect the needs and priorities of their communities.

Gypsy and Traveller Accommodation Assessment

- 2.9. The Government published a new Planning Policy for Traveller Sites (PPTS) on 25th March 2012 to be read in conjunction with the National Planning Policy Framework. This was revised by the Government in August 2015.
- 2.10. Salford University were jointly commissioned with Ashford and Gravesham Borough Councils in September 2012 to prepare new Gypsy and Traveller Accommodation Assessments (GTAA). Part One of the new assessment for TMBC dealing with Gypsies and Travellers was completed in April 2013. Part Two dealing with Travelling Showpeople was completed in October 2014. The Housing and Planning Act 2016 removes the requirement to prepare GTAAs, but Local Authorities will in future have to carry out periodic reviews of their housing needs, including those for caravans and houseboats. At the time of writing new Government guidance on how to prepare these reviews was awaited.
- 2.11. In the absence of the awaited guidance, the Council has appointed consultants Arc4 to prepare updated evidence on Gypsy, Traveller, Travelling Showpeople and Houseboat accommodation needs. This evidence is expected before the end of 2017.

Community Infrastructure Levy

2.12. The Council has not decided to prepare a CIL to date. The NPPF is clear that, where practical, Community Infrastructure Levy (CIL) charges should be worked up and tested alongside the Local Plan (para.175). With this in mind, the Council will not progress with CIL until detailed progress has been made with the new Local Plan. Given that the starting point for CIL is a clear understanding of the growth level that the new Local Plan will address, the infrastructure needed to support it and, most importantly, the infrastructure

funding gap, it is not possible for meaningful work to be undertaken for CIL until these pieces of work have been completed. We await the Government's response to the recommendations of the independent panel set up to review CIL.. The Council will keep a watching brief on these matters.

Sustainability Appraisal

2.13. The new Local Plan has and will be subject to a Sustainability Appraisal (SA). This SA process will comply with the requirements of the Environmental Assessment of Plans and Programmes Regulations 2004. These Regulations implement the requirements of the Strategic Environmental Assessment Directive (EU Directive). The Scoping Report was approved by the Council in February 2015 and was subject to consultation with the statutory consultees. An Interim Sustainability Appraisal and Habitats Regulations Assessment (Screening Report) were published and consulted upon alongside the 'Local Plan – The Way Forward' document.

Duty to Co-Operate

- 2.14. In preparing the new Local Plan for Tonbridge and Malling, which began shortly after the NPPF was published in 2012; officers have worked closely with neighbouring authorities in accordance with the Duty to Cooperate. Specific examples include the joint commissioning of consultants (e.g. Strategic Housing Market Assessments and Gypsy and Traveller Accommodation Assessment), liaising with Kent County Council over the delivery of future service and infrastructure provision and contributing to cross boundary projects, such as Medway Council's Rochester Airport Masterplan.
- 2.15. In the year to 31st March 2017 officers have worked closely with Maidstone Borough Council in respect of their Local Plan Hearing and Main Modifications consultations. In addition, there have been regular meetings between the three West Kent Local Authorities of Tonbridge and Malling Tunbridge Wells and Sevenoaks, regarding Local Plan preparations, responding to the implications of the Wealden Judgement and seeking positive and proactive ways of addressing community housing initiatives . Regular meetings have also been held with Gravesham and Medway Councils to the north to better understand Local Plan progress and any cross boundary issues, particularly in respect of future growth on the North Downs Special Conservation Area.
- 2.16. On a more strategic level, officers continue to work closely with Kent County Council in preparing the Local Plan evidence base, particularly in respect of the potential infrastructure requirements of new development arising from the Local Plan. T&M are also liaising with the Mayor for London and the Greater London Authority in respect of the forthcoming review of the London Plan, expected to be published later in 2017..

South East Plan

2.17. In previous AMR's housing targets were set by the South East Plan, which was revoked in March 2013. The 2017 AMR covering the period to the 31st March 2017 is based on a current objectively assessed need for housing, which has been calculated in accordance with the Government's NPPF and the National Planning Practice Guidance.

Self-Build & Custom House Building Register

2.18. Further to the Self-Build and Custom Housebuilding Act (2015) Tonbridge and Malling Borough Council has prepared a Register of eligible individuals and associations who wish to build their own home in the Borough. The purpose of the Register is to provide valuable information on the level of demand for self-build and custom housebuilding locally. Certain public bodies have a duty to have regard to the registers when carrying out their functions in relation to planning, housing, land disposal and regeneration. 2.19. The Register is in the process of being reviewed in the light of new regulations that were brought into force during 2016-17.

Green Belt

- 2.20. A Green Belt Study has been prepared which considers the robustness of the current Green Belt in the borough against the NPPF criteria, and also provides a broad assessment of each area.
- 2.21. A further study is underway to identify parcels of land that could be released from the Green Belt in order to secure a sustainable pattern of development to meet housing need where it occurs in the emerging local plan strategy.
- 2.22. As part of the 'Local Plan The Way Forward', and drawing on the evidence base, it has been suggested that the Green Belt could be extended around the West Malling Area.

Statement of Community Involvement (SCI)

- 2.23. It is also a requirement that Local Planning Authorities prepare a Statement of Community Involvement (SCI) to explain how it will consult on planning matters. A revised SCI was adopted in November 2014.
- 2.24. The Borough Council is very keen to hear from local residents, communities, businesses and other organisations on the 'Local Plan The Way Forward' document, which formed the basis of public consultations between 30th September and 25th November 2016 (Regulation 18).

Flooding

2.25. A Strategic Flood Risk Assessment (SFRA) was completed in September 2016. This takes into account the latest flood risk policy following key changes to policy and guidance that have occurred since the previous SFRA was published (2006 plus the 2011 updated mapping) and takes into account the latest flood risk information and available data. It goes without saying that the issue of flood risk is crucial to the location of new development.

Historic & Natural Environment

2.26. The new Local Plan will continue to recognise the rich historic and natural environment in Tonbridge and Malling and these will be taken into consideration in planning to meet our future needs for development. As before there will be a preference for previously developed land to come forward before greenfield sites are considered, although it may not be possible to identify sufficient land to meet all our needs in this way.

Employment

- 2.27. The 2014 Employment Land Review has shown that there is sufficient employment land allocated to meet future needs and there is an imbalance between land allocated for office use, of which there is too much and land for other types of employment, of which there is not enough.
- 2.28. Since this report was published, a number of changes have occurred and an update is currently underway. This update is due to be published later this year.

The New Local Plan

- 2.29. In response to the publication of the National Planning Policy Framework, Council Members have agreed to the production of a new Local Plan. This new Plan, once adopted, will form part of the Council's Development Plan and will replace the current suite of adopted local plans. The new Plan will have a time horizon up to 2031.
- 2.30. In the interim, the suite of adopted local plans and any adopted Neighbourhood Plans will continue to represent the core of the Council's Development Plan, having been prepared under the Planning and Compulsory Purchase Act 2004.
- 2.31. For more information please look at the Councils webpage www.tmbc.gov.uk/localplan.

Housing

- 2.32. This AMR deals with the 2016/17 period after the SEP was revoked. The SEP required the provision of 450 units per year on average, which is a total of 6,750 units between 2006 and 2021 (the LDF Plan period). In March 2014 a new Strategic Housing Market Assessment (SHMA) was completed which identified the Objectively Assessed Need (OAN) for the Borough. The SHMA was updated in August 2014 in response to the 2012-based Sub National Population Projections. Following the publication of the Government's 2012-based Household Projections in February 2015 a further 2 updates of the SHMA was undertaken. The final report emerged in September 2016 that recognised the current Objectively Assessed Need which is 696 units per annum; 13,920 units in total for the period 2011-31. It is on this basis that we have assessed the current housing land supply position, substituting the 450 from 2013/14 onwards because this was the first year after the abolition of the SEP.
- 2.33. Figure A2 of this note sets out the housing trajectory for the Borough. The trajectory tracks the provision of housing supply over the lifespan of the adopted LDF (2006-2021). The purpose of the trajectory is to highlight the robustness and soundness of the overall housing strategy in the adopted DPDs and how it is performing in relation to the annualised housing requirements (OAN). The trajectory highlights the following information:
 - Past dwelling completion rates
 - Projected future dwelling completion rates (excluding windfalls)
 - Dwelling requirement annual net additional dwelling requirement from the South East Plan from 2006 to 2013 (450 units per year up to and including 2012/13) and the annual net additional dwelling requirement from the new assessment of objectively assessed needs (OAN) for housing in accordance with the NPPF, which is 696 units per year.
- 2.34. The housing trajectory in Figure A2 is based upon the projected phasing of housing development as set out in Figure A1 (excluding outstanding allocations which do not enjoy planning permission). The trajectory also includes data on **managing** (Figure A3) and **monitoring** (Figure A4) housing delivery. The manage line indicates the under or oversupply of dwellings at any one point. This is calculated by subtracting the completions to date from the total cumulative allocations and then dividing the answer by the number of years remaining in the LDF period. The monitor line demonstrates how many dwellings above or below the planned rate the LDF strategy is at any point in time. This is calculated by subtracting the cumulative annualised allocation from the SEP and now the OAN, year by year.
- 2.35. **Five Year Housing Supply** Figure A1 confirms that at 31 March 2017 Tonbridge and Malling Borough Council can demonstrate **95%** of the OAN requirement (including + 5% buffer) for the next five year period to (2017/18-2021/22); a shortfall of 199 dwellings

below the requirement. An additional buffer of 5% has been applied because the cumulative completions chart (p.12) demonstrates that the Borough Council has a good record of housing delivery over the longer term (dating back to 2006), i.e. there is no record of persistent under-delivery.

- 2.36. Housing Supply to 2021 Figure A2 confirms that at 31 March 2017 Tonbridge and Malling Borough can demonstrate 95% of the OAN requirement for the set plan period to 2021. Since the Plan began a total of 6,885 units have so far been completed. This level of supply is partly as a result of the Secretary of State's decision in November 2004 to support the Borough Council in granting planning permission for the development of three major sites at Kings Hill (750 units), Holborough Quarry (1,000 units with an additional 250 units permitted in 2009) and Leybourne Grange (723 units, including the conversion of a Listed Building and associated development). In May 2006 the Borough Council added to this by approving an outline application at Peters Pit for 1,000 dwellings. In addition, the Council resolved to grant planning permission for 635 units as part of Phase 3 at Kings Hill in November 2014.
- 2.37. Looking over the lifetime of the adopted LDF so far, the trajectory illustrated in Figure A3 highlights that a healthy land supply for residential development has been achieved, with cumulative completions consistently exceeding cumulative requirements. It should be observed that this is the first reporting period (2016/17) when the Council has not been able to demonstrate a five year housing land supply (4.7 years). It should be noted that supply is affected by wider economic factors beyond the control of the Borough Council, such as the recession in 2008 and the subsequent slow recovery of the economy, which resulted in a notable downturn in completions. Whilst this is not unique to Tonbridge & Malling, the influence of these wider economic factors on the housing market which the Borough Council has no bearing upon should not be underestimated.
- 2.38. Locally, the marked increase in the number of residential schemes within Tonbridge town centre since the base date of the LDF has slowed. In 2016/17 a total of 142 units were completed compared to the previous year of 319 units which included the 196 flats completed at the Sovereign House development, and 70 at Cannon Lane Depot. Previously the committed permissions for the Tonbridge Central Area showed that in 2016/17 198 units were anticipated, 56 units more than were actually built. The committed permissions to be built in 2017/18 is a further 67 units. These lower numbers are due to the characteristics of the development, i.e. flatted developments such as Sovereign House, Black Horse House at Medway Wharf Road, and Canon Lane Depot that have now been built out.
- 2.39. As at the 31 March 2006 base-date of the Plan, Annex A in the Development Land Allocations DPD showed that planning permission already existed for some 4,606 dwellings which were due to be implemented during the Plan period. It was recognised that the yield on these sites could vary if revised planning permissions were granted. A number of significant planning permissions have been granted since 31 March 2006. As at 31 March 2017 there were 3,596 net units with planning permission still to be implemented. The outstanding commitment at the end of each year had been decreasing, which is to be expected as the plan is implemented, and the slight slowing of completions or lack of implementation of permissions due to wider market conditions beyond the control of the Council. Sites such as Peters Pit, Phase 3 of Kings Hill, Cannon Lane Depot, Tonbridge are coming forward but phasing has been pushed back due to various reasons including external factors. Many of the extant permissions are for flats which are classed as completed only once the whole building has been finalised and signed off.

- 2.40. Over the last 5 years these unimplemented planning permissions were mainly windfall permissions and the reserved details for Kings Hill, Phase 3 for Kings Hill, Leybourne Grange and Holborough, as well as the 1,000 dwelling outline permission at Peters Pit, which has now risen to 1,059. In addition to these sites with planning permission there are also the unimplemented housing allocations in the Development Land Allocations DPD. Figure 2 shows a simplified table of the 2016/17 housing completions and commitments over the next 5 years.
- 2.41. Land at Bushey Wood is identified as a Broad Area of Opportunity for future development under Policy CP16. This land continues to be safeguarded.
- 2.42. The Peters Pit site is well under construction with the bridge being built over the River Medway and the road links to the A229 now complete, however the new Medway Crossing to serve the new Peters Village community and neighbouring area was temporarily closed for some 10 days early this year after remedial work. Peters Village developer Trenport said the work was required after its contractor fitted incorrect expansion joints to both ends of the bridge roadway deck and footpaths - the bridge reopened on 10 February.
- 2.43. The phasing has been agreed with the developers with the first completions were registered in 2016/17 as anticipated. The developers have also advised that an average annual rate from 150 up to 186 dwellings a year can be achieved.
- 2.44. Kings Hill Phase 3 has been agreed by Liberty and that an annual average rate of 100 dwellings a year can be achieved with the first completions set for Summer 2018.
- 2.45. The last area of Kings Hill Phase 2 is looking to complete in 2018/19. The allocation remainder of 65 units has no permissions as yet.
- 2.46. Leybourne Grange has 302 units remaining out of a total of 731 permitted on the site, and looks set to be complete in the next 3 years.
- 2.47. Holborough has 408 remaining on permissions out of a total of 1250 on the original permission. The new school replaced 87 units and the new total on the outline permission was reduced to 1163 units. There are 121 units remaining on the outline permission and phases 6,7 & 11, and 8,9 & 10 are all yet to be completed over the next 6 years.

Housing for older people

2.48. The need to provide housing for older people is significant given that over half of the population change between 2011 and 2031 is projected to occur in the group of people aged 65 and over (Office for National Statistics 2014-based Sub-National Population Projections). The Borough Council's Strategic Housing Market Assessment (SHMA) (March 2014 Report) assesses the need of older person households and this important piece of evidence will inform the making of the new Local Plan. During plan-making the Borough Council will need to consider the size, location and quality of dwellings needed in

the future for older people in order to allow them to live independently and safely in their own home for as long as possible, or to move to more suitable accommodation if they so wish. Supporting independent living can help to reduce the costs to health and social services, and providing more options for older people to move could also free up houses that are under occupied for families.

2.49. Figure A5 shows the completions and extant of C2 use class permissions as at 31st March 2017. There are 101 completions of C2 units and 151 extant units. The table also shows 151 demolitions which is the old Woodgate Residential Care Home in Tudeley Lane Tonbridge, Abbeyfield Residential Care Home in Larkfield, and Abbeyfield Greensted Residential Home in Wateringbury.

Commercial & Economic Development

- 2.50. Audits of commercial land are produced for each local authority in Kent, on a yearly basis by districts in conjunction with Kent County Council. They provide information on the number of completions by use class, rates of development set out in Development Plan Documents and planning permissions on a site-by-site basis including those developments completed, not started or under construction. The Commercial Information Audit will be published by both Tonbridge & Malling Borough Council and KCC in early 2018.
- 2.51. During 2016/17 112,656 m² of gross floorspace was developed for employment (A2 and B1-B8 uses) within the Borough. This is considerably higher than the previous year's figure (2015/16). This year saw a rise in the completion of mixed B1 and B8 which included the completion of a number of larger schemes at Snodland Paper Mill, Nepicar Park Wrotham & Priory Works in Tudeley Lane, Tonbridge.
- 2.52. 2016/17 also saw record losses of approximately 194,762 m², the result being a net loss of 148,944m². This is predominantly due to the demolition of Aylesford Newsprint, loss of B2 in Snodland Paper Mill and 2-8 Morley Road Tonbridge as well as the conversion of offices to residential development across the Borough.
- 2.53. 2016/17 saw extant planning permissions for commercial/retail (A2/B1-B8) for a total of 63,402m² not started and 3,436m² under construction.
