LAA Conclusion	The site is located to the north of Church Lane and south of Green Lane. The site is a greenfield site, wholly within a National Landscape and is wholly within the Green Belt. The site is on Grade 2 agricultural land (Best and Most Versatile - BMV), adding a further constraint related to the loss of productive land. Trottiscliffe is considered to be an unsustainable settlement with limited services and facilities and therefore residential development is considered to be unsuitable on sustainability grounds.



LAA Conclusion	The site is located south of Coldrum Lane, east of Pinesfield Lane. It comprises an agricultural field with hedgerows to the northern and western boundaries. To the southwest corner of the site is a dwelling. North of the site are dwellings fronting Pinesfield Lane. The site is located within the Green Belt and is also within the Kent Downs National Landscape. It is remote from any settlement boundary and as such is considered to be an unsustainable location for development. Due to the unsustainable location, coupled with the Green Belt and National
	Landscape designation of the site, it is considered that the site is unsuitable for development.
