

It comprises an agricultural field and is bounded to the north, south and west by the wider field and to the east are School Lane, Reed Lane and the semi-detached dwellings. The site is located within the Green Belt, and Kent Downs National Landscape. It is remote from any settlement boundary and therefore is considered to be an unsustainable site. Any development would result in harm to the National Landscape and due to this, as well as the Green Belt location and the unsustainable nature of the site, it is considered that the site would not be suitable for development.









The site is located within the Green Belt and the western and northwestern boundaries are areas of Ancient Woodland and the site also contains a protected tree within the grounds of Stanley Lodge. The site is remote from any settlement boundary and therefore is considered to be an unsustainable location for development. Given the presence of an irreplaceable habitat and also the Green Belt and unsustainable location

of the site it is considered to be unsuitable for development.

It is remote from any settlement boundary and therefore is considered to be an unsustainable site. For this reason and that the site is within the Green Belt and due to the Ancient Woodland constraining the site further it is considered that the site would be unsuitable for development.











The site is comprised of an agricultural field and is bounded to the south by brook, to the west by a public right of way which is tree lined and another brook to the east. The site is wholly within the Green Belt and Kent Downs National Landscape. Any development of the site would result in harm to the National Landscape. Part of the eastern



LAA Conclusion

The site is located to the east of Coldharbour Lane. It comprises an open field to the northern part of the site with a wooded section to the southern part of the site. To the south of the site a dwelling 'The Spinney' and to the northwest of the site is the dwelling 'Paddock View'. The site is bounded to the north by woodland. The site has no natural access to Coldharbour Lane and does not front the lane. The site is within the Green Belt and the woodland to the north is protected by TPO with part of the easter part of the woodland which bounds the site being Ancient Woodland, an irreplaceable habitat. The site is also remote from any settlement boundary and therefore is considered to be an unsustainable site. Given the Green Belt Location, the lack of frontage onto Coldharbour Lane, the presence of protected trees to the north and irreplaceable habitat to the northeast of the site as well as the unsustainable location the site is considered to be unsuitable for development.







	Given that this site is remote from the defined boundary of any settlement, it is considered to be unsuitable for development.






